Chrysanthe E. Vassiles is a partner that concentrates her law practice in the creditors' rights/bankruptcy, collections, and business areas. Career highlights include:

- Represented Chapter 7 trustee in bankruptcy case involving complicated contested matters and adversary proceedings, culminating in global settlement amongst debtor, debtor's wife, another Chapter 7 trustee, largest unsecured creditors, and administrative claimants, successfully stemming the ongoing litigation.
